SUPPLEMENTARY FOUNDING AFFIDAVIT

I the undersigned,

WYNANDA WILHELMINA COETZEE

make oath and say that:

- I am an adult female attorney practising as such at the firm Geyser & Coetzee Attorneys (the "Class Legal Representative"), with its address at 9 Baobab Nook, Centurion, Gauteng.
- 2. The facts set out in this affidavit are within my personal knowledge, save where otherwise indicated or where the contrary appears from the context, and are to the best of my belief both true and correct.

- 3. I deposed to a founding affidavit on 7 February 2020, filed with the above Honourable Court on or about the same date (the "Founding Affidavit").
- 4. It has come to my attention that I made an error in paragraph 15.2 of the Founding Affidavit, where I stated that "the parties began substantively engaging on the legal fees after the signature date of the settlement agreement".
- 5. What in fact happened was that the negotiations on an agreed amount to be paid in full and final settlement of the Class Legal Representative's legal fees and disbursements began after the parties to the settlement agreement had agreed upon all the terms of the settlement agreement that confer benefits on Class Members and that impose duties on the parties respectively to give effect to those benefits, but before the signature date of that agreement. Those agreed terms included clause 9 of the settlement agreement, in terms of which the Class Legal Representative waived the right to pursue consideration from any source other than the Fifth Applicant.
- 6. Schedule 7 to the settlement agreement served only to record the quantum of the Fifth Applicant's contribution and the parties' unanimous approval of the quantum, and was appended on the parties' common assumption that the quantum would only be agreed after the signature date. As it turned out, due to multiple factors, including late but immaterial drafting amendments to the settlement agreement and the logistics of securing the several signatories' signatures meant that the settlement agreement and Schedule 7 were signed simultaneously.
- 7. I also take this opportunity to confirm that, of the R18 million plus Value Added Tax payable in full and final settlement of the Class Legal Representative's legal fees, the Fifth Applicant has by agreement with the Class Legal Representative, already paid an amount equivalent to the taxed value of the costs orders awarded in favour of the First and Second Applicants/

in 2018, in respect of the exceptions applications in this Court, the Supreme Court of Appeal and the Constitutional Court, being an amount of R3 744 721.00, plus Value Added Tax. The total amount, with Value Added Tax, being R4 306 429.15, was paid to the Class Legal Representative on 29 January 2020. A copy of the proof of payment is annexed hereto marked "SFA1".
